

#### **ATLS Fee Schedule**

The following fee schedule outlines tuition fees, stipends for administration, and indirect costs paid to the Florida Committee on Trauma (FCOT) for all Advanced Trauma Life Support (ATLS) courses held in Florida.

The Advance Trauma Life Support ("ATLS") course is an integral part of the optimal care for trauma patients in Florida. The American College of Surgeons ("ACS") provides the state Committees on Trauma (COT) the opportunity to outline the costs paid to the state COTs role in managing the approval process for new ATLS sites, supporting ATLS educator costs, and the ensuring administration of state COTs consistent with the policies of the ACS.
